Information about the Title

This title is designed to help the auditor efficiently and effectively perform financial statement audits and, when applicable, audits of internal control over financial reporting, of common interest realty associations in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Knowledge-Based Audit™ Methodology is a risk-based methodology that emphasizes using knowledge of the entity to make risk assessments in connection with a financial statement audit. This allows the auditor to more appropriately focus audit efforts on those areas which in the auditor's judgment are the most significant and pose the most risk of material misstatement to the financial statements.

Conducting audits of common interest realty associations requires the exercise of the auditor's professional judgment. Additionally, the operations of common interest realty associations are often unique and complex and may require specialized accounting and auditing knowledge. This edition includes specific up-to-date guidance for auditing common interest realty associations.

This document is published for the purpose of communicating the updates and enhancements included in the current version to users of the toolset. This document is not, and should not be used as, an audit program to update the audit documentation of an engagement started in a previous version of this product.

New in this Release

2024 Edition of Knowledge-Based Audits of Common Interest Realty Associations

This edition features numerous enhancements, including:

- · Removing the audit area "Accounting Estimates"
- Adding new identification of Accounting Estimates by audit area in Table I of KBA-400 Scoping and Mapping of Significant Account
 Balances, Classes of Transactions, and Disclosures
- Any "X" in this new identification column will flow to Table III in KBA-400 just as specific risks which means the auditor should also
 identify each of these accounting estimates in the risk pane and select the risk as "Significant Accounting Estimate" for identification
 purposes

- Each of these accounting estimates added in the risk pane will be required to have a separate risk assessment performed in KBA-502 Summary of Risk Assessments
- Updating KBA-502 Summary of Risk Assessments to separate out each assertion based on the audit area, specific risk or significant
 accounting estimate
- Updating KBA-503 Basis for Inherent Risk Assessment to comply with SASs 143 and 145. KBA-503 will now be a Foundation workpaper and will reset on rollforward
- The "Link to Risk" column in the Audit Programs will reset all "Specific Risk" and "Other Relevant Assertion" selections from the prior binder. All specific risks and assertions related to the audit area will now need to be linked individually
- Updating AUD-818 Audit Program: Accounting Estimates to remove the program step library and make the workpaper a multiple instance. The prior version of this workpaper will be obsolete and will need to be deleted by the user.
- Updating KBA-105 Review of Significant Accounting Estimates to comply with SAS 143
- This workpaper is a foundation workpaper and must be inserted after rolling forward. The prior version of this workpaper will be obsolete and will need to be deleted by the user.
- Removing flow of "Factors to Consider" from KBA-200 to KBA-101 due to duplication, please note these factors are removed from KBA-200
- Many wording changes in procedures due to SASs 142 145
- Enhancing instructions and procedures throughout the toolset to improve workflow based on SASs 142 145

CCH® ProSystem fx® Engagement 2022 Compatibility

This title can be installed on Engagement v2022 by first installing the Engagement v2022.2.3 Update. The latest update can be downloaded via CCH Software Delivery Manager. This update allows you to use the 2024 content without installing Engagement v2023 until your firm plans to update.
