Information about the Title

This title is designed to help the auditor efficiently and effectively perform financial statement audits and, when applicable, audits of internal control over financial reporting, of Health Care Entities in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). The Health Care Entities covered in this edition are: (a) depository and lending institutions, (b) credit unions, (c) banks and savings institutions, (d) finance companies, and (e) mortgage banking companies. The Knowledge-Based Audit Methodology is a risk-based methodology that emphasizes using knowledge of the entity to make risk assessments in connection with a financial statement audit. This approach allows the auditor to focus audit efforts on the areas which, in the auditor's judgment, are the most significant and pose the most risk of material misstatement to the financial statements.

Conducting audits of Health Care Entities requires the exercise of the auditor's professional judgment. Additionally, the operations of nonpublic Health Care Entities are often unique and complex and can require specialized accounting and auditing knowledge.

This document is published for the purpose of communicating the updates and enhancements included in the current version to users of the toolset. This document is not, and should not be used as, an audit program to update the audit documentation of an engagement started in a previous version of this product.
