### Information about the Title

This title is designed to help the auditor efficiently and effectively perform financial statement audits and, when applicable, audits of internal control over financial reporting, of public entities in accordance with auditing standards promulgated by the PCAOB. The Knowledge-Based Audit Methodology is a risk-based methodology that emphasizes using knowledge of the entity to make risk assessments in connection with a financial statement audit. This allows the auditor to focus audit efforts more appropriately on those areas which in the auditor's judgment are the most significant and pose the greatest risk of material misstatement to the financial statements. The Knowledge-Based Audit Methodology is also designed to help the auditor efficiently and effectively perform examinations regarding compliance reports or reviews regarding exemption reports of broker or dealer entities in accordance with the PCAOB attestation standards, as applicable.

This document is published for the purpose of communicating the updates and enhancements included in the current version to users of the toolset. This document is not, and should not be used as, an audit program to update the audit documentation of an engagement started in a previous version of this product.

The 2024 title includes CCH® Accounting Research Manager® material links to specific guidance, providing instant access to detailed analysis related to the steps and processes discussed in the workpapers.

# CCH® ProSystem fx® Engagement 2024 Compatibility

This title can be installed on Engagement v2022 by first installing the Engagement v2023.2.2 Update. The latest update can be downloaded via CCH Software Delivery Manager. This update allows you to use the 2024 content without installing Engagement v2023 until your firm plans to update.
